Our institution is committed to promoting environmental sustainability and reducing our ecological footprint. To achieve this goal, we have formulated a policy to establish a green campus and eliminate the use of single-use plastics.

Green Campus Initiatives:

- ➤ Implementation of energy-efficient practices and renewable energy sources to reduce carbon emissions.
- Adoption of water conservation measures such as rainwater harvesting and up-gradation of traditional surface water (Pond water) to safe drinking water.
- ➤ Promotion of sustainable transportation options such as cycling, walking, and public transit along with circular of restricted automobile like "No vehicle day" once in a week.
- ➤ Pedestrian friendly pathways: Vehicle parking space is provided at the main entrance of the college campus. As the campus is vehicle free with some exceptions, students and staff experience comfort walking through the pedestrian friendly pathways. The internal roads are lined with trees and they are properly maintained by the campus maintenance committee.
- ➤ Enhancement of green spaces on campus through tree planting, landscaping with native plants, and creating wildlife habitats.
- ➤ Integration of environmentally friendly practices into campus operations, including waste reduction, separate bins for solid, liquid, e-waste, recycling of bio-waste programs, and composting.

Plastic-Free Campus Initiatives:

- ➤ Prohibition of single-use plastics including plastic bags, straws, cups, utensils, and bottles on campus premises. To restrict the use of plastic, measures have been taken to replace plastic tea cups and glasses with steel glasses in the canteen. The staff and students are informed to use steel or copper water bottles instead of plastic bottles and cloth bags instead of plastic carry bags.
- ➤ Installation of water refill stations to facilitate the use of reusable bottles and reduce reliance on bottled water.
- ➤ Collaboration with vendors and suppliers to ensure that products supplied to the campus are plastic-free or packaged in eco-friendly materials.
- ➤ Education and awareness campaigns to inform students, faculty, and staff about the environmental impacts of plastic pollution and the importance of adopting plastic-free practices.

Compliance and Enforcement:

- ➤ All members of the campus community are expected to adhere to the green campus and plastic-free policies.
- Regular monitoring and evaluation will be conducted to assess compliance with the policies and identify areas for improvement.
- ➤ Non-compliance may result in penalties or disciplinary actions as outlined in the campus guidelines.


